The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Improve the north side of Liberty Mills Road from Middle Grove to Falls Drive and the west side of Falls Drive from Liberty Mills to Coventry Lane with a 10-foot wide asphalt trail, connecting Aboite residents with the Village at Coventry. The project includes a boardwalk, ADA curb ramps, retaining walls, signage, a park bench, pavement markings and erosion control measures.
