The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Work to include: constructing an 8 ft wide concrete trail on the west side of Hanna from Rudisill Boulevard to Pettit Avenue, new curb ramps with APS, new drive approaches, addition of one storm structure and removal of selected trees in the park strip.
