### **Goeglein Rd Sidewalk Connection: Maysville Rd to Stellhorn Rd**

Sealed bids will **ONLY** be received and accepted via the online electronic bid service through [www.questcdn.com](http://www.questcdn.com) until **9/12/2024 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

**Renovating the Goeglein Road corridor by installing new 5' wide concrete sidewalk along the east side of Goeglein Road from Maysville Road to Stellhorn Road and along the south side of Maysville Road from Sandarac Lane to Goeglein Road. It will improve connectivity for the residents of Briargate, Park State East and Hacienda Village. Concrete drive approaches and new ADA curb ramps along with upgraded storm sewer infrastructure is included. The large diameter multi-plate pipe arch storm structure conveying the Bullerman Ditch under Goeglein Road at Stellhorn Road will be extended for construction of the sidewalk.**

All in accordance with the Bidding Documents and Drawing No. ST- **0337S** as prepared by **Transportation Engineering** for the City of Fort Wayne, Indiana.
