The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

**Construct concrete wing walks and ramps to ADA compliance, including new tactile warning devices. Also, upgrades to adjacent sidewalks and curb, inlet castings, replacing concrete and asphalt streets and restoration. Proposed ramps will be located in all 6 Districts of the city**
