Sealed bids will ONLY be received and accepted via the online electronic bid service through www.questcdn.com until **7/21/2022 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

A north-south alley in the Williams-Woodland Park Neighborhood Association bounded by W. Taber St. to the north, W. Suttentfield St. to the south, Hoagland Ave. to the west and Webster St. to the east. The existing historic brick alley and asphalt approaches will be removed and replaced with a twelve foot (12') wide brick alley, new concrete approaches and curbface sidewalk. Minor stormwater adjustments along with curb and restoration are included with this project as well.
