NOTICE is hereby given by the Board of Public Works of the City of Fort Wayne, Indiana, that sealed bids for:

Wheelock Rd Trail: Stellhorn Rd to Jefferson Middle School

Sealed bids will **ONLY** be received and accepted via the online electronic bid service through www.questcdn.com until **1/30/2025 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Improve Wheelock Road by installing a 10' wide asphalt trail on the west side of Wheelock Road starting at Jefferson Middle School and then heading south to Stellhorn Road where the trail then continues to the West, on the North side of the Road, crossing the Bullerman Drain before stopping 500' West of Wheelock Road. ADA ramps, drainage upgrades, a park bench, and regrading of a detention pond will be included in the project. The trail will be paid for using Tax Increment Financing from the Redevelopment Commission.
