Sealed bids will **ONLY** be received and accepted via the online electronic bid service through www.questcdn.com until **6/27/2024 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

An east-west and north-south alley in the Oxford Community Association bounded by E Wildwood Ave to the south, Colerick St to the north, Lafayette St to the west and Warsaw St to the east. The existing 12' wide alley and approaches will be removed and replaced with a 12' wide concrete alley, new concrete approaches at E Wildwood Ave, Colerick St and Warsaw St, 5' concrete sidewalk along E Wildwood Ave, curbface sidewalk along Colerick St and Warsaw St and residential drive approaches where needed. Minor stormwater adjustments along with curb and parkstrip restoration are included with this project as well.
