Bids submitted shall be publicly displayed at the Board of Public Works, 200 E. The funding source for this project is WATER.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Victoria Park Water Main Replacement as follows:

Installation of 1,090' of 2" and 7,840' 6" HDPE pipe by horizontal directional drilling including hydrants, valves, services, and all other appurtenances.

all in accordance with the Bidding Documents as prepared by City Utilities Engineering.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.

A Pre-Bid Conference will be held on 11/12/2024 at 1:00pm local time at the Citizens Square, 200 East Berry Street, Suite 250, Conference Room 260, Fort Wayne, Indiana 46802 to familiarize prospective bidders with the proposed project and to answer any questions.
