The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Anthony And Pettit Water Main Replacement as follows:

Installation of approximately 1,900 feet of 16" and 11,500 feet of 12" HDPE water main by horizontal directional drilling along with hydrants, valves, services, and all other appurtenances.
