The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Kruse Homestead Addition Water Main Extension as follows:

**Installation of 4,280' of 6" and 1,340' 16" HDPE pipe by horizontal directional drilling including hydrants, valves, services, and all other appurtenances.**
