**Orders the installation of approximately 1,800 LF of 48" consolidation sewer installed via open cut installation and installation of 250LF of an inverted siphon river crossing. Work includes a diversion structure and associated appurtenances including hatches, adjustable weir, slide gate and floatable control to convey combined sewer to 3RPORT.**
