The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, FLP to WWPS Power Resiliency Improvement Phase 1 as follows:

Installation of 8130' of 2" and 6130' of 6" HDPE conduit by horizontal directional drilling. Project also includes an alternate for pulling 8990' of owner furnished fiber optic and 8800' of owner furnished power cables.

all in accordance with the Bidding Documents as prepared by City Utilities Engineering.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.
