The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Pond 1 Sheet Piling Removal as follows:

Removal of approximately 1600 LF of 20 sheet piles located in Wet-Weather Storage Pond 1 at the Water Pollution Control Plant.
