Vallyd Acres Septic Elimination Project CONTRACT/RESOLUTION NUMBER 77271

Bids submitted shall be publicly displayed at the Board of Public Works, 200 E. Berry Street, Suite 210, conference room 220 Fort Wayne, IN 46802 immediately following and posted for viewing at www.questcdn.com.

The funding source for this project is American Rescue Plan Act Funds.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Vallyd Acres Septic Elimination Project as follows:

Installation of approximately 6,600 LF of 8" gravity sanitary sewer to provide service to 30 homes on failed or failing septic systems

all in accordance with the Bidding Documents as prepared by the City Utilities Engineering Department, City of Fort Wayne, IN.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.

A Pre-Bid Conference will be held on 11/4/2024 at 1:00pm local time at the Citizens Square Room 255 200 E. Berry Street Fort Wayne, IN to familiarize prospective bidders with the proposed project and to answer any questions. There will also be an online meeting at the same time with meeting details provided through Quest. Prospective bidders may attend in person or the online meeting.
