The funding source for this project is STORMWATER UTILITY REVENUE.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Pierson Drain Improvements Phase II - Lake Avenue and River Greenway Culvert Upgrades as follows:

Installation of 80 lf of 12'x5' concrete box culvert, 26 lf of 20'x6' concrete box culvert, and minor existing storm sewer realignments. Project also includes installation of two-stage ditch including flexamat, 1,170 lf of pre-vegetated coir log, gravel access drive, and restoration.

all in accordance with the Bidding Documents as prepared by the City Utilities Engineering Department, City of Fort Wayne, Indiana.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.

A Pre-Bid Conference will be held on 7/22/2024 at 1:00:00 AM local time at the Citizens Square Room 255 to familiarize prospective bidders with the proposed project and to answer any questions. There will also be an online meeting at the same time with the meeting details provided through Quest. Prospective bidders may attend in person or the online meeting.
