- 4. Approval of Professional Services Agreement between the City of Fort Wayne and Catalyst Public Affairs Group for Regulatory and Governmental Support Services. Compensation for services performed shall be \$60,000.00.
- 5. Approval of Professional Services Agreement between the City of Fort Wayne and DLZ Indiana for Future Service Area Planning for Cells 13 and 14. Compensation for services performed shall not exceed \$35,000.00.
- 6. Approval of Professional Services Agreement between the City of Fort Wayne and Jacobs Engineering for WO #76802, WPCP MCC P1 Replacement 2021, Construction Management & Resident Project Representative Services. Compensation for services performed shall not exceed \$31,834.00.
