SUMMARY

The incumbent is expected to exercise good judgment, independence, initiative, and professional expertise in conducting day-to-day operations. All work duties and activities must be performed in accordance with the City and Utility's safety rules and operating regulations, policies and procedures as well as federal, state, and local regulations.

- Maintains equipment, tools and work area;
- Dismantles equipment and structures;
- Repairs or replaces hydrants as assigned;
- Makes push or tap to install hydrants, water mains and valves;
- Installs or repairs service, curb and valve boxes;
- Assists in repairing roadways, sidewalks and curbs;

MARGINAL FUNCTIONS

- Performs general maintenance work as assigned;
- Performs similar or less skilled work;
- Performs other duties as required.
